This template can be used for multiple purposes:

 It enables schools to effectively plan their use of the Primary PE and sport premium

 It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium

 It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

necessary that spending has to meet all the key priorities, you should select the priorities that you aim to use any funding towards.

This has enabled more children to enjoy the physical activity.

Year 6 attended Robin wood for their residential trip. Year 1, 3, 4, 5 attended day visits to Hothersall lodge taking part in a variety of physical activity and new experiences in the outdoors. They showed their resilience, teamwork, determination and courage and enjoyed trying new physical activities which they have not tried before.

Teachers have been able to effectively evidence and assess children using the app. This has shown a good progression in their learning and they have made good progress. We will continue to use this next year as we have also used some money to sign up for the next three years. This will enable the progress to be continued to be made for all children and effective teaching and assessment.

Staff have had a wide range of CPD which going forward will allow the school and the pupils to continue to make good progress in the children's physical literacy. Children will further develop their fundamental movement skills after a course on this which we have noted as a need for our school.

More children have been able to meet the national curriculum standard of being able to swim 25m and perform self rescue due to being able to offer the catch up swimming lessons this year.

Olympic theme day

Children have really enjoyed taking part in the PE lessons delivered by the sports coaches and staff have gained a wealth of ideas and knowledge in different ways to teach the sports we have on our curriculum.

The theme day was a huge success – the children took part in a wide range of Olympic activities and Para-Olympic activities too. They were able to demonstrate a wide range of their physical literacy skills and took part in a range of activities that they would not normally be able to access.
